BILLING INFORMATION

Invoices for services are emailed with each requested document. Monthly statements are emailed to customers by the 7th day of each month as a service to our customers. All customers are responsible for monthly payment of invoices regardless of whether such invoices were actually received.

All charges invoiced to a customer shall be deemed to be valid and undisputed unless the customer disputes such charges in writing within 15 days after the invoice is e-mailed by ANAdeeds to the customer. Each customer is responsible for payment for all services provided to such customer by ANAdeeds.

PAYMENT AGREEMENT

Payment is expected immediately upon completion and delivery of the requested documents. The purchase price for payment for any Products shall be made within 30 days of invoice subject to prior credit approval. In addition to any other right or remedy it may have, ANAdeeds shall be entitled to interest at a rate equal to the lesser of 1 1/2% per month and the maximum allowed by law on all payments over 90 days past due plus all costs and expenses of collection. Purchaser shall be responsible for all applicable taxes, duties and fees required. Prices and other terms and conditions are subject to change by ANAdeeds upon written notice.

CANCELLATION
